Thank you for contacting us!

We appreciate you bringing up accessibility compliance, especially in light of the upcoming WCAG requirements in Europe. This is definitely a priority area for us as well.

While we don't currently have public documentation or a roadmap available, I can confirm that we are actively working on improving accessibility across our plugins, starting with Instagram Feed. Our development team is focusing first on the most critical accessibility issues, and these updates are being rolled out gradually. Full compliance with WCAG is a long-term goal, and we're committed to moving in that direction.

At the moment, we don't yet offer built-in options for adding custom alt descriptions to images or controlling focus states for keyboard navigation, but these are exactly the types of improvements we're keeping in mind as we work on accessibility updates. I've passed your feedback along to our team so it can help inform our ongoing efforts.

We'll also keep your request in mind for future documentation.

I hope this helps, and please let us know if you have any other questions or need further attention.
